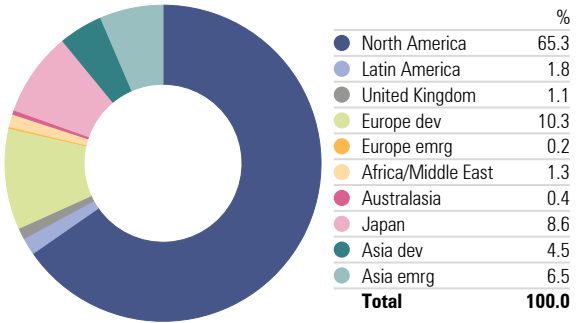

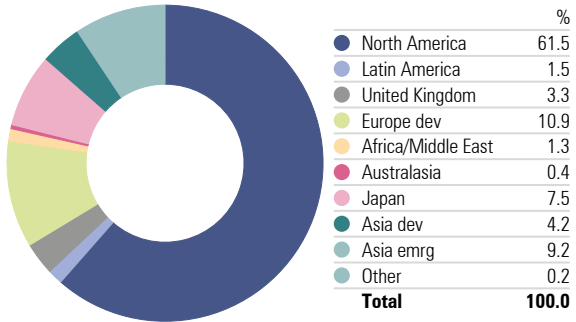
EQUITY REGIONAL EXPOSURE

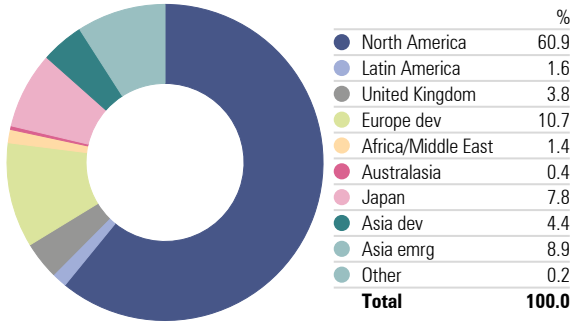
