



INVESTMENT FOCUS

INVESTMENT MANDATE

The Impact Portfolio aims to produce enhanced returns through direct or indirect exposure to green energy and agricultural assets. A minor allocation towards land or property financing and transaction financing is included. The mandate includes allocations into South African as well as global opportunities. The fund aims to minimise cash allocations required for liquidity.

ASSET CLASS DESCRIPTION

The asset classes in the asset allocation pie chart have the following meanings:

Green Energy Fund

The Fedgroup Green Energy Fund provides investors with access to risk-mitigated returns in a portfolio consisting of green energy underlying assets deployed on verified sites across the country. Since 2016, Fedgroup has amassed extensive experience in running a green energy fund with full vertical and horizontal integration in the supply chain, from an EPC, to metering, billing and collections as well as monitoring of each site and the systems on these sites.

Smart Agri Fund

The Fedgroup Smart Agri Fund provides investors with access to risk-mitigated returns in a portfolio where the underlying assets are investments into agricultural assets generating returns for the fund. Environmental and social elements are essential to the underlying assets and play a key role in the fund.

Enhanced Property Finance Fund

The Fedgroup Enhanced Property Finance Fund provides investors with exposure to structured property finance deals, offering compelling returns on a risk-adjusted basis with investments secured by second covering mortgage bonds and other related securities.

Private Capital Fund

The Fedgroup Private Capital Fund provides investors with access to a specialised alpha product. This unlisted instrument is designed to outperform current benchmarks offered by most fixed-return products by investing funds into various asset classes.

Enhanced Cash Fund

Objective is to achieve superior returns in excess of a typical money market fund with an emphasis on capital preservation while maintaining a high degree of liquidity.
